## General Terms and Conditions Erlebniskletterwald

1. Every participant is obliged to read these General Terms and Conditions (GTC) before entering the climbing forest. With his signature he confirms for himself and the accompanying participants to have read and accepted these GTCs. **The legal guardians of under aged participants have to read these GTCs and talk them over with the under aged participants before entering the climbing forest. The legal guardian confirms this with his signature on the registration form.**

**2. Every participant is walking at his own peril in the whole complex.**

In case of injuries by screw connections, steel ropes, rope pulleys, splinters, parts of exercises, branches, rough terrain and so on, or in case of damage of for instance pieces of cloth, mobile phones, cameras etc. the operator is not taking responsibility. Liability of the operator in case of malice is not affected by this.

3. All visitors at the age of over 8 years and the height of 1.30m are allowed in the complex, unless they have any health detriment that endangers their own and / or other people's health when entering the climbing forest. At the height of 1.30m – 1.40m visitors need to be accompanied by an adult. Children and adolescents up to 18 years need to be accompanied by an adult while climbing. Alternatively, they can bring a declaration of consent of their legal guardian saying that they are allowed to visit the climbing forests without any legal guardian. With his signature the legal guardian confirms to have read the GTCs and talked them over with his child/ren. Persons under the influence of alcohol or drugs are not permitted to enter the climbing forest.

4. No objects that can endanger the participant himself or others by e.g. falling down are permitted when entering the climbing forest. (bags, backpacks, jewelry, watches, mobile phones, camera etc.) Long hair has to be done short in an appropriate way (hairnet, hair tie etc.) to prevent them of getting stuck in elements, steel ropes, exercises and pulleys.

5. All instructions and decisions given by the operator are binding. In case of violations or contraventions of instructions given by the operator, participants concerned may be excluded of the climbing forest without any claim to refund of their entrance fee. In case of violations or contraventions of instructions given by the operator, the operator cannot be made liable for any resulting damages, accidents and injuries. Accidents, property damage or injuries have to be reported immediately.

6. **Every guest has to attend the security instructions before entering the climbing forest.** The rented equipment (helmet, climbing harnesses etc.) have to be used like in the security instruction. It is not transferable to others and must not be taken off during any time in the climbing forest. The equipment has to be returned three hours after being handed, unless an additional team or partner parkour is booked. In case of exceeding these three hours the operator may demand additional payment of 5€ per 30 minutes. The climbing complex must not be left with the rented equipment.

7. The operator reserves the right to fully or partly close the complex for safety reasons (storm, thunderstorm, rain, etc.). In this case no refund will be given. If the guest ends his visits prematurely on his own request he/she has no claim to fully or partly refund of the entrance fee.

8. Every exercise between the platforms in the trees can only be done by one person at the same time at maximum. An exception is the Partner Parcour where 2 people are allowed at the same time. Three persons at the same time are allowed on the platforms at maximum. In order to prevent a hard impact on the trees and platforms, **hands must be used for braking when sliding down the zip lines.** The zip lines must only be used after making sure that no person is standing in the arrival area of the arrival platform or ground.

9. **Smoking is not permitted** in the whole climbing complex, especially while wearing the climbing harnesses.

10. The making of photographical or film material for commercial purposes is prohibited in the whole area of the Erlebniskletterwald. The operator reserves the right to take photos and make films for his own advertising and informational purposes. In case a participant does not agree with this policy, he is ought to report this explicitly to the operator beforehand.

11. In case of missing participants of announced groups the operator reserves the right to demand entrance fee from absent participants that exceed the tolerated 10% of announced and confirmed groups.

12. **Every guest always has to secure himself with the karabiner . The security karabiner always have to be linked with the security rope or slide, at no time both karabiners must be taken off.**

13. If any clause of these GTC is ineffective, the relating legal regulation takes its place. The remaining clauses are not affected by that.
